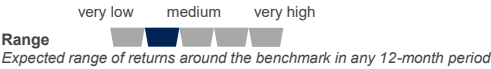
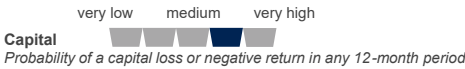

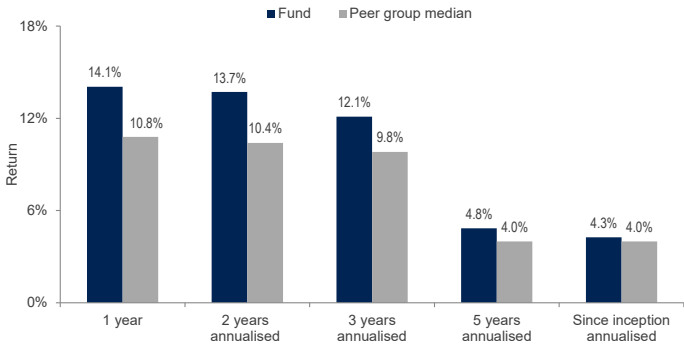

Investment objective

The investment objective of the fund is to achieve capital appreciation over capital preservation during the full investment cycle. The fund is ideally suited to investors with a high risk tolerance and an investment horizon of 5 years or longer. The Fund intends to achieve its investment objective through a diversified global portfolio primarily consisting of investments in participatory interests of portfolios of collective investment schemes or other similar schemes.

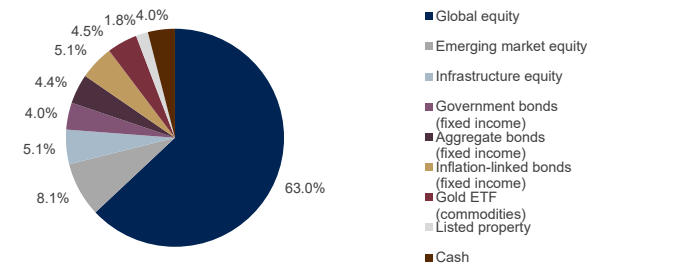

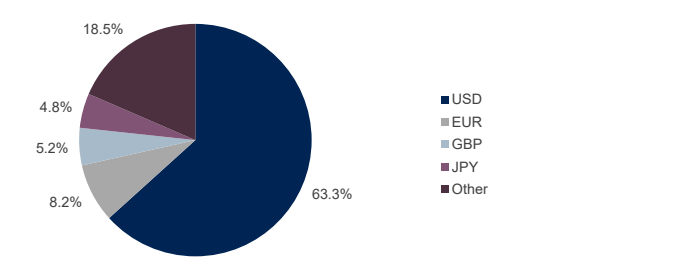

■ Market commentary

Global equity markets experienced a volatile but ultimately flat month in July. Beneath the headline index level, however, performance dispersion across regions, sectors and investment styles was significant, highlighting a broadening of market leadership after a prolonged period of narrow returns.

Market sentiment continued to be driven by fluctuations in US-Iran geopolitical tensions and the associated implications for inflation. Although US inflation data came in below both expectations and May levels, renewed concerns around higher oil, commodity and shipping costs fuelled expectations of more persistent inflationary pressures. This contributed to a notable rise in global bond yields, with the US 10-year real yield ending the month at 2.4%, while the 30-year real yield rose above 3% for the first time since 2008.

Higher real rates and elevated investor positioning prompted profit-taking across several previously strong market segments. Korean equities were particularly volatile, with the KOSPI experiencing extreme swings amid speculative activity linked to newly approved leveraged single-stock ETFs. Semiconductor stocks also came under pressure, with the Philadelphia Semiconductor Index declining around 20% during the month.

Technology and AI themed shares faced a more challenging backdrop as tighter financial conditions weighed on sentiment. SpaceX shares ended July near US\$108, more than 50% below their post-listing peak and below the IPO price. Meanwhile, margin debt in the US reached a record US\$1.5 trillion, underscoring the extent of leverage within parts of the market and contributing to heightened volatility. Highly leveraged AI hedge fund, Situational Awareness, was reportedly forced to liquidate positions shortly after month-end, further highlighting these risks.

Fixed income markets also delivered modestly negative returns as rising oil prices and inflation concerns pushed yields higher despite no changes in major central bank policy rates. Corporate bonds benefitted from higher income yields but were unable to fully offset capital losses from rising rates. Currency markets saw notable moves, particularly in the Japanese yen, which strengthened sharply following coordinated intervention efforts aimed at supporting the currency.

While market volatility remains elevated, the continued broadening of equity returns and improving support for quality-oriented investments are constructive developments. We believe a diversified asset allocation combined with active management leaves portfolios well positioned to navigate further uncertainty and capitalise on opportunities created by market dislocations.

■ Impact of underlying manager costs

Underlying manager costs (per annum):
This will depend on the managers selected for inclusion in the Fund. Managers typically charge fees for investment management (which may include performance fees) and administration, among other costs.
Currently the cheapest manager costs 0.10% per annum and the most expensive manager costs 1.05% per annum. The overall cost of the current manager blend is 0.54%. The methodology for calculating these figures is described in the Total Expense Ratio footnote on page 1.
