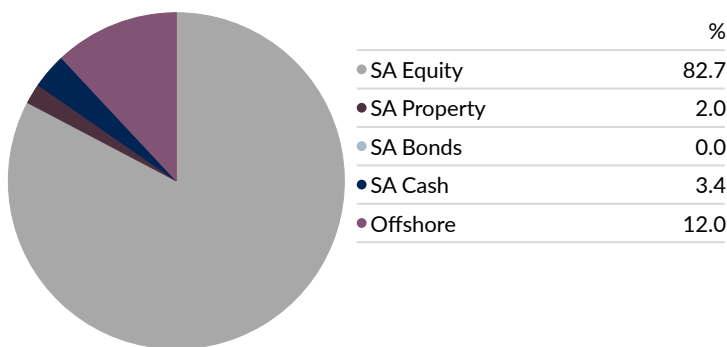

Fund Objective and Investment Policy

The investment objective of the fund is to provide investors with diversified exposure to predominantly the South African equity market. The fund aims to achieve long term capital growth. Investments to be included in the fund will, apart from assets in liquid form, consist solely of collective investment schemes. The fund will be actively managed and may have exposure to general equity as well as specialist portfolios. The equity exposure will be at least 80% at all times, and the fund may hold up to 45% in foreign assets.

Portfolio Managers Comment

The FG SCI Mercury Equity Fund of Funds returned +1.86% for the month of July, outperforming the benchmark FTSE/JSE All Share Total Return index which returned +1.18%, and the peer group average return of +1.52%. Global financial markets experienced volatility during the month as the ceasefire between the US and Iran came to an end, pushing oil prices higher and reigniting concerns about inflation. US inflation came in significantly lower than expected at 3.5%, down from 4.2% in the previous period and well below the consensus forecast of 3.8%. US employment data was weaker than anticipated, with non-farm payrolls coming in below expectations, while the unemployment rate decreased to 4.2%, largely due to a lower labour force participation rate of 61.5%. The US Federal Reserve kept interest rates unchanged at 3.5% to 3.75%. However, neither the accompanying statement nor the subsequent press conference provided clear guidance on the Fed's future policy direction, unsettling markets. Locally, South African inflation rose sharply to 5.0% from 4.5% in the previous month, significantly higher than market expectations of 4.7%. The South African Reserve Bank (SARB) unexpectedly left interest rates unchanged at its meeting in the final week of July. This decision surprised markets, particularly given the higher-than-expected inflation reading released two days earlier, as well as the renewed surge in oil prices following the re-escalation of the US-Iran conflict during the month. Local listed property (SAPY) was the best-performing asset class, returning 2.30%. Local listed equities (FTSE/JSE All Share Index) outperformed emerging market equities, with the MSCI Emerging Markets Index declining by 3.03%, while the local market returned 1.18%. Performance was supported by resources (+2.06%), financials (+1.34%), and industrials (+0.30%). The PSG Equity Fund was the best performing underlying fund, returning +4.24% for the month. No changes were made to the fund over the month.

From 01 Apr 2023 to 31 Mar 2026, 1.35% (A Class) and 1.63% (C Class) of the value of the financial product was incurred as expenses relating to the administration of the financial product. 0.29% (A and C Class) of the value of the financial product was incurred as costs relating to the buying and selling of the assets underlying the financial product. Therefore 1.64% (A Class) and 1.94% (C Class) of the value of the financial product was incurred as costs relating to the investment of the financial product.

Graviton Financial Partners (Pty) Ltd has been appointed as the Investment Advisor of the GFM Global Fund range, for which they earn an investment advisory fee of up to 0.345% on the A class and up to 0.3675% on the C class, on the value of investments in the Fund. Certain financial advisors/members of the FGAM investment committee are direct / indirect shareholders of the SIP Mauritius and Graviton Group of companies. As a shareholder, these individuals may earn direct or indirect dividends on the value of investments in the FGAM offshore fund. As investment manager of the Fund, CiGFM will earn an investment management fee of up to 0.565% on the A class and up to 0.6925% on the C class, on all such investments.
